Puppy Contract

Breeder Responsibility- Puppy will come with tail docked (unless requested by buyer), dew claws removed, fully vetted (appropriate shots, de-wormer, health certificate if applicable) and microchipped. Shot records and veterinary consent to sell will be given to you on the day of sale. Here at CFC, we also believe in finding the best home for our puppies; therefore, we are available to you for advice (before, during, and after the puppy's transition) once you get your puppy home, if you should need it. We reserve the right to not sell to anyone.

Buyer's Responsibility- The puppy will need to see your vet within 72hrs upon pick up (excluding weekends). If your vet finds a critical problem with your puppy, not including stress or environmental changes, it is your responsibility to contact the breeder (myself) immediately. We will discuss what further actions need to be taken at that time. The puppy will come microchipped, however, you will have to take further steps in registering your new puppy's chip number to your information. Steps to do this will be given to you at the time of sale. Shipping costs are paid by buyer. Buyer is responsible for keeping puppy up to date on shots and additional treatments (flea & tick, de-wormer) at buyer's expense once possession is transferred. This puppy, as assumed, is a lifetime commitment; however, if unforeseen circumstances occur and you can no longer adequately care for the puppy, it is required that you contact me (with first rights for rehoming) vs. putting the puppy in a shelter, etc.

Shipping- As stated above, the buyer is responsible for all shipping costs concerning the puppy purchased. The breeder is not liable for any injury/death to puppy due to stress or environmental change once placed in the shipper/buyers care.

Health Guarantee- The puppy will come with a one-year health guarantee. This does not include illnesses that can be contracted through environmental settings (parvo, internal parasites, coccidia, kennel cough, etc.), but does include problems caused by genetic issues (hip dysplasia, degenerative myelopathy, etc.).

Deposit/Payment - The buyer will place a \$300.00 non-refundable, transferable deposit on the puppy of their choice. Should the buyer decide they no longer want the puppy, the deposit is forfeited. The deposit will go towards the balance due on the puppy. The entire balance of the puppy is to be

paid before the puppy leaves the breeder's care. Payments can be scheduled up until the puppy is delivered. If paying at the time of pick up, personal checks are not accepted. Payment is accepted through Venmo, PayPal or cash.

IF any legal action is to occur, it will be held in Adams County, Illinois at the expense of whom is at fault.
